Continuing a practice begun in 1990, BEDFORD TAXPAYERS ASSOCIATION (BTA) offers its suggestions on HOW TO VOTE on candidates and warrant articles on March 14

TOWN:

Article 1: ELECTION OF TOWN OFFICES

TOWN COUNCIL: BTA endorses only James Barrett because he is the only proven fiscal conservative running. As a Business Owner, President and CFO, plus being a very involved Bedford volunteer citizen for the last 8 years, Jim clearly has the background, experience, and financial skills to accomplish Town Council goals. BTA is certain that we do NOT need another lawyer on the Council, especially one who has only lived in Bedford for 2 years.

TOWN CLERK: BTA endorses Lori Radke because she has served as a helpful, caring, and very competent Town Clerk for 9 years.

Article 2: ZONING AMENDMENTS

ZONING AMENDMENT 1. BTA cannot support this proposed amendment because the actual content to be added to the regulations is not shown on the Ballot. **Vote NO (X)**

ZONING AMENDMENTS 2 & 3. These are simple housekeeping amendments to clarify language concerning location, size, and use of Accessory Apartments **Vote YES (X)**

ZONING AMENDMENT 4. This amendment is intended to clarify the requirements for separate accessory buildings and their allowed use. **Vote YES (X)**

ZONING AMENDMENT 5. This amendment specifies methods which may be used to test acceptable locations for proposed cellphone towers. **Vote YES (X)**

ZONING AMENDMENT 6. This amendment adds allowed uses to the Office District.

Vote YES (X)

ZONING AMENDMENT 7. This is a simple housekeeping amendment to correct several typographical errors. Vote YES (X)

ZONING AMENDMENT 8. This has been withdrawn by the petitioner.

Vote NO (X)

Article 3: PROPOSED CHARTER AMENDMENT

This is a rewording recommended by the Town Lawyer to clarify the timing of any future proposed increase in compensation for members of the Town Council. **Vote YES (X)**

SCHOOL DISTRICT:

Article I: ELECTION OF SCHOOL DISTRICT OFFICERS

There are No Contested Positions

Article II, IV, VI: NEGOTIATED AGREEMENTS for STAFF Combined cost is \$808,567 because the increase for II is reduced by decreases for IV and VI. Passing these will also require all staff to pay more of their own Medical Insurance cost from now on.

Article III, V, VII: CONDITIONAL ARTICLES

These 3 articles allow for Special Meetings if Articles II, IV, VI do not pass. Such meetings are costly, poorly attended, and allow decisions by a very small number of voters.

Vote NO (X)

Article VIII: OPERATING BUDGET Projected cost is \$71,221,547. This is an **INCREASE** of \$2,206,516 over this year's budget. It is \$587,399 more than the Default Budget of \$70,634,148, which is \$1,619,117 more than this year's Operating Budget!! But the School population is not increasing. The number of students in Bedford's Schools has been essentially the same for the last 3 years and is projected to remain the same for the next 3 years. Defeating the Operating Budget and living with the Default Budget, will not cause any education program cuts. All staff salaries and raises are included in the Default Budget as well as special education costs (with a 6% increase). Since last year's Operating Budget ended with a surplus of \$2.4 million, we can assume another surplus by the end of this year as well. We will also be getting funds from the State of NH which are still owed to us by court ruling, and the dormant Trusts found last year still have another half million dollars just sitting there for when there is a need. There is no possibility that the Default Budget will be inadequate even for unexpected costs.

Vote NO (X)

If Article VIII is defeated you will slow the increase in your taxes for next year. For the last 17 years Bedford's School District Operating Budget has increased by an average of \$2.5 million per year. That is over \$42.5 million, which has caused property taxes to double on an average Bedford home. The time has come to call a halt to perpetual School District tax increases.
